PROCEEDINGS OF THE COMMITTEE - - - - - p. 7

DUBLIN CORPORATION BILL AND CLONTARF URBAN DISTRICT COUNCIL BILL.

[*Monday, 19th March 1900*]:—Dublin Corporation Bill and Clontarf Urban District Council Bill (by Order).

Resolved, That it is expedient that the Dublin Corporation Bill and the Clontarf Urban District Council Bill be committed to a Joint Committee of Lords and Commons.

Ordered, That a Message be sent to the Lords to communicate this Resolution, and to desire their concurrence.—(*The Chairman of Ways and Means*.)

[*Friday, 23rd March 1900*]:—Message from the Lords.—Dublin Corporation Bill and Clontarf Urban District Council Bill,—That they concur with the Commons in their Resolution, “That it is expedient that the Dublin Corporation Bill and the Clontarf Urban District Council Bill be committed to a Joint Committee of Lords and Commons.

[*Thursday, 5th April 1900*]:—Resolution of the House of the 19th day of March, relative to the Dublin Corporation Bill and the Clontarf Urban District Council Bill, which was ordered to be communicated to the Lords, and the Message from the Lords of the 23rd day of March signifying their concurrence in the said Resolution, read:—

Ordered, That the Dublin Corporation Bill and the Clontarf Urban District Council Bill be committed to a Select Committee of Four Members nominated by the Committee of Selection to be joined with a Committee of four Lords.

That all Petitions in favour of or against the Bills, presented five clear days before the meeting of the Committee, be referred to the Committee; that the Petitioners praying to be heard by themselves, their Counsel, or Agents, be heard in favour of or against the Bills, and Counsel heard in support of the Bills.

That a Message be sent to the Lords to acquaint their Lordships that the Dublin Corporation Bill and the Clontarf Urban District Council Bill have been committed to four Members of this House, to be joined with a Committee of four Lords pursuant to the Resolution of the House of the 19th day of March, and to the Message from the Lords of the 23rd day of March signifying their concurrence thereto.—(*The Chairman of Ways and Means*.)

[*Tuesday, 1st May 1900*]:—Mr. Halsey reported from the Committee of Selection; That they had nominated the following four Members to serve on the Joint Committee of Lords and Commons on the Dublin Corporation Bill and the Clontarf Urban District Council Bill:—Mr. Whitmore, Sir Robert Mowbray, Sir Ughtred Kay-Shuttleworth, and Mr. Harwood.

[*Friday, 11th May 1900*]:—Message from the Lords,—That they have appointed a Committee, consisting of four Lords, to join with the Committee of the Commons (pursuant to Message of this House of the 5th April), to consider the Dublin Corporation Bill and the Clontarf Urban District Council Bill; and they propose that the said Joint Committee do meet in Committee Room A, on Thursday next, at Two o'clock.

Lords' message considered.

Ordered, That the Committee of this House do meet the Lords Committee as proposed by their Lordships.

R E P O R T.

THE SELECT COMMITTEE appointed to join with a Committee of the House of Lords to consider the Dublin Corporation Bill and the Clontarf Urban District Council Bill :—HAVE agreed to the following REPORT ;—

That in the case of the Dublin Corporation Bill, the Bill gives no powers relating to police or sanitary regulations.

That the Bill does not give any powers which might have been obtained by means of bye-laws made subject to the restrictions of general Acts already existing.

That the Bill does not assign a period for the repayment of any loan, or for the redemption of any charge or debt under the Bill exceeding the term of forty years, or any period disproportionate to the objects of the loan.

That the Bill does not give borrowing powers for any purposes for which such powers already exist or may be obtained under general Acts.

That in pursuance of Standing Order No. 173, a Certificate of the Local Government Board for Ireland was laid before the Committee stating that the application for the Bill was made with the sanction and approval of the Board.

That no Report from any Government Department relative to the Bill has been referred to the Committee.

That there are no other circumstances of which, in the opinion of the Committee, it is desirable that the House should be informed.

Further that they had examined the allegations contained in the Preamble of the Bill and amended the same so as to make it consistent with the provisions of the Bill as passed by the Committee, and found the same as amended to be true, and had gone through the Bill and made Amendments thereunto.

THE SELECT COMMITTEE appointed to join with a Committee of the House of Lords on the Dublin Corporation and Clontarf Urban District Council Bills :—HAVE also agreed to the following SPECIAL REPORT :—

That in the case of the Dublin Corporation Bill they have approved the Bill with certain Amendments, among which are those excluding the two townships of Rathmines and Rathgar, and of Pembroke, from the extensions of the boundary of the City of Dublin.

Further, the Committee unanimously desire to call attention to the heavy burdens falling upon the City of Dublin ratepayers for objects to which the two townships of Rathmines and Pembroke do not in their opinion adequately contribute.

They are of opinion that these residential townships should be contributors to these burdens.

They invite the attention of the Government to this subject, and suggest that legislation should be proposed to Parliament following the principle of the law equalising rates in London.

The Committee have come to the unanimous conclusion that it would be a public advantage if there were one administration to control the drainage and sewers and treatment of the sewage for Dublin and the two townships. They think that it would be absurd if one part of the sewage were treated at Pigeon House Fort, and other parts discharged a little distance away, within the sea-walls of the bay, without corresponding treatment. They are also of opinion that the whole community benefits by the great works now being carried out for purifying the Liffey. And they recommend that legislative steps should be taken to constitute a joint Drainage Board for the City and the Townships of Rathmines and Pembroke—representing the Corporation and the two Urban District Councils—and to distribute over the entire area the past and future burden of both systems of drainage.

THE SELECT COMMITTEE appointed to join with a Committee of the House of Lords, to consider the Dublin Corporation Bill and the Clontarf Urban District Council Bill ;—HAVE agreed to the following REPORT :—

That in the case of the Clontarf Urban District Council Bill, the Bill gives no power relating to police or sanitary regulations in conflict with deviation from or excess of the provisions or powers of the general law.

That the Bill does not give powers which can be obtained by means of bye-laws made subject to the restrictions of general Acts already existing.

That the Bill does not assign a period for the repayment of any loan or for the redemption of any charge or debt under the Bill exceeding the term of sixty years or any period disproportionate to the duration of the works to be executed or other objects of the loan, charge, or debt.

That the Bill does not give borrowing powers for any purposes for which such powers already exist or may be obtained under general Acts.

That the borrowing powers given by the Bill, the purposes for which the loans are authorised, and the period assigned for the repayment, appear in the Appendix.

That in pursuance of Standing Order No. 173 a Certificate of the Local Government Board for Ireland was laid before the Committee stating that the application for the Bill was made with the sanction and approval of the Board.

That no Report from any Government Department relative to the Bill has been referred to the Committee.

That there are no other circumstances of which, in the opinion of the Committee, it is desirable that the House should be informed.

Further, that they had examined the allegations contained in the Preamble of the Bill, and amended the same so as to make it consistent with the provisions of the Bill as passed by the Committee, and found the same as amended to be true, and had gone through the Bill and made Amendments thereunto.

The following SPECIAL REPORT was read, and *agreed to* :—

“ That the Committee have approved the Bill with certain Amendments, among which are those excluding the two townships of Rathmines and Rathgar, and of Pembroke, from the extensions of the boundary of the City of Dublin.

“ The Committee unanimously desire to call attention to the heavy burdens falling upon the City of Dublin ratepayers for objects to which the two townships of Rathmines and Pembroke do not in their opinion adequately contribute.

“ They are of opinion that these residential townships should be contributors to these burdens.

“ They invite the attention of the Government to this subject, and suggest that legislation should be proposed to Parliament following the principle of the law equalising rates in London.

“ The Committee have come to the unanimous conclusion that it would be a public advantage if there were one administration to control the drainage and sewers and treatment of the sewage for Dublin and the two townships. They think it would be absurd if one part of the sewage were treated at Pigeon House Fort, and other parts discharged a little distance away, within the sea-walls of the bay, without corresponding treatment. They are also of opinion that the whole community benefits by the great works now being carried out for purifying the Liffey. And they recommend that legislative steps should be taken to constitute a Joint Drainage Board for the City and the Townships of Rathmines and Pembroke, representing the Corporation and the two Urban District Councils, and to distribute over the entire area the past and future burden of both systems of drainage.”
