

ORDER OF REFERENCE.

[Monday, 22nd February 1909]:—Remission of Surcharges (Dublin) Bill,—To discharge certain surcharges made upon the accounts of the Municipal Corporation of Dublin, presented by Mr. Nannetti; supported by Mr. Harrington, Mr. Field, and Mr. Waldron; to be read a second time on Monday next, and to be printed.

[Tuesday, 27th April 1909]:-Bill read a second time.

Bill committed to a Select Committee of Five Members, Three to be nominated by the House and Two by the Committee of Selection.

Ordered, That all Petitions against the Bill presented Five clear days before the meeting of the Committee be referred to the Committee.

Ordered, That the Petitioners praying to be heard by themselves, their Counsel, their Agents, be heard against the Bill, and Counsel heard in support of the Bill.

Ordered, That the Committee have power to send for persons, papers, and records.

Ordered, That Three be the Quorum.-(Mr. Nannetti.)

[Thursday, 3rd June 1909]:-Mr. Hugh Barrie, Mr. Menzies, and Mr. Nolan nominated Members of the Select Committee on the Remission of Surcharges (Dublin) Bill.-(Mr. Joseph Pease.)

[Tuesday, 8th June 1909]:-Committee of Selection,-The following Members are nominated Members on the Select Committee on the Bill:-Mr. Glendinning and Mr. Charles Craig.

Preamble read the first time.

A Report from the Local Government Board of Ireland was read.

Mr. Nannetti, a Member of the House, was heard in support of the Preamble of the Bill.

Mr. Greer, attending by desire of the Committee, made a statement on behalf of the Local Government Board of Ireland.

The Committee deliberated.

Preamble read a second time.

Question, That the Preamble is proved-put, and agreed to.

Clauses considered, and agreed to.

New Clause (Payment of Auditor's Costs), brought up and read the first time as follows:--"There shall be paid by the Corporation to the Auditor all costs necessarily and properly incurred in and about the proceedings hereby annulled."

New Clause read a second time and added to the Bill.

Ordered, To Report the Bill, as amended, to the House.
