But it is to be recollected that this approximation must be considerably in excess of the number permanently evicted, since this table merely shows the number of Tenants and Sub-Tenants turned out of their holdings, and not re-admitted on the same day, without giving any indication as to the number of these who may or may not afterwards be re-admitted as Tenants, Sub-Tenants, or Caretakers.

NOTE 2.—The figures given in Column (1) have been obtained from the Superior Courts and from the Clerks of the Peace, and it is found impossible to furnish statistical information which would approach accuracy as to the number of Sub-Tenants who may be affected by the Ejectment Notices upon Tenants.
