OVERENSKOMST af 22 April 1871

for de FORENEDE KONGERIGER  
STORBUTANNEN og IRLAND og  
GENERALPOSTDIREKTORATET for  
KONGERIGET DANMARK.

The Postmaster General of the United Kingdom of Great Britain and Ireland and the Director General of Posts of the Kingdom of Denmark have agreed as follows :

#### ARTICLE I.

Telegraph Money Orders for sums not exceeding the maximum amount allowed in the case of ordinary Money Orders, shall be exchanged between Denmark and the United Kingdom of Great Britain and Ireland. The Postal Administrations of the two countries shall each indicate to the other the Offices which they admit to this exchange of Telegraph Money Orders.

#### ARTICLE II.

The sender of a Telegraph Money Order shall be required to pay, in addition to the commission to be fixed and retained by the country of origin, the cost of a telegram of advice from one country to the other.

Independently of the charges above mentioned the British Post Office reserves to itself the right to levy from the sender of each Telegraph Money Order from the United Kingdom to Denmark a supplementary charge, the amount of which will be fixed and retained by the British Post Office.

#### ARTICLE III.

All Telegraph Money Orders payable in the United Kingdom shall be transmitted to the Central Telegraph Office in London, but those payable in Denmark shall be transmitted direct to the Offices of payment.

In cases of Telegrams of Advice to places in the United Kingdom except London, the words "viâ London" should appear in the preamble as a service instruction.

Generalpostmesteren for de forenede Kongeriger Storbritannien og Irland og Generaldirektøren for det Kongelige danske Postvæsen ere blevne enige om følgende :

#### ARTIKEL I.

Telegram-Postanvisninger paa Beløb, der ikke overskride det Maksimumsbeløb, der er fastsat for almindelige Postanvisninger, kunne udveksles mellem Danmark og de forenede Kongeriger Storbritannien og Irland. De to Landes Postbestyrelser skulle underrette hinanden om, hvilke Posthuse der skulle deltag i denne Udveksling af Telegram-Postanvisninger.

#### ARTIKEL II.

Afsenderen af en Telegram-Postanvisning er pligtig til et betale foruden den Porto, der fastsættes og indeholdes af Afsendelseslandet, Taksten for et Anmeldelses-telegram fra det ene Land til det andet.

Uafhængig af de ovenomhandlede Afgifter forbeholder den britiske Postbestyrelse sig Retten til at afkræve Afsenderen af enhver Telegram-Postanvisning fra de forenede Kongeriger til Danmark en Tillægsafgift, hvis Beløb fastsættes og indeholdes af den britiske Postbestyrelse.

#### ARTIKEL III.

Alle i de forenede Kongeriger betalbare Telegram-Postanvisninger skulle sendes til Hoved-Telegrafstationen i London, men de i Danmark betalbare skulle sendes direkte til Udbetalingsposthusene.

Telegram - Postanvisninger til andre Steder i de forenede Kongeriger end London skulle foran være forsynede med Ordene "viâ London" som en tjenstlig Bemærkning.
