HEREAS it is expedient that a complete System of Preamble. Registration of Births and Deaths should be established in Ireland, as in other Parts of the United Kingdom: Be it

enacted by the Queen's most Excellent Majesty, by and with the 5 Advice and Consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the Authority of the same, as follows :

Preliminary.

1. This Act may be cited for all Purposes as "The Registration of Short Title. 10 Births and Deaths (Ireland) Act."

2. This Act, except as herein otherwise provided, shall extend to Act to ex-Ireland only.

3. The following Words and Expressions shall, in construing this Interpretation Clause. Act, be taken and understood to have the Meanings hereby assigned
