TO

Confirm certain Provisional Orders of the Local Government A.D. 1913. Board for Ireland relating to the Urban Districts of Carlow Galway and Larne and the City of Dublin.

THEREAS the Local Government Board for Ireland (hereinafter referred to as "the Local Government Board") have made the Provisional Orders set out in Schedules A. C. and D. hereto under the Public Health (Ireland) Acts 1878 to 1907 and 5 the Provisional Order set out in Schedule B. hereto under those Acts and the Local Government (Ireland) Act 1898:

And whereas it is requisite that the said Orders should be confirmed by Parliament and that the provisions herein contained should be enacted with reference to those Orders:

Be it therefore enacted by the King's most Excellent Majesty 10 by and with the advice and consent of the Lords Spiritual and Temporal and Commons in this present Parliament assembled and by the authority of the same as follows:--

1. The Orders set out in the schedules hereto are hereby Orders in 15 confirmed and all the provisions thereof shall have full validity schedules confirmed. and force.

2. The local authorities mentioned in the Orders hereby Restriction confirmed shall not under the powers of those Orders purchase of power to take houses or acquire in any urban district any house which on the fifteenth of working 20 day of December last was occupied either wholly or partially class. by thirty or more persons belonging to the working class as tenants or lodgers or except with the consent of the Local Government Board any house which was not so occupied on the said fifteenth day of December but has been or shall be 25 subsequently so occupied.

A.D. 1913. If either of the said authorities acquire or appropriate any house or houses for the purposes of the Order relating to their district in contravention of the foregoing provisions they shall be liable to a penalty of five hundred pounds in respect of every such house which penalty shall be recoverable by the 5 Local Government Board by action in the High Court and shall be carried to and form part of the Consolidated Fund of the United Kingdom Provided that the Court may if it think fit reduce such penalty.

For the purposes of this section the expression "house" 10 means any house or part of a house occupied as a separate dwelling and the expression "working class" means mechanics artizans labourers and others working for wages hawkers costermongers persons not working for wages but working at some trade or handicraft without employing others except members 15 of their own families and persons other than domestic servants whose income does not exceed an average of thirty shillings a week and the families of any of such persons who may be residing with them.

Short title. 3. This Act may be cited as the Local Government Board 20 (Ireland) Provisional Orders Confirmation (No. 2) Act 1913.

- The district council shall be empowered to put in force with reference to the lands described in the schedule hereto and for the purpose aforesaid the powers of the Lands Clauses Acts as amended
 by section 8 of the Public Health (Ireland) Act 1896 with respect to 59 & 60 Vict. the purchase and taking of lands otherwise than by agreement or any c. 54. of them.
- 2. The costs and expenses of the district council and the Local Government Board for Ireland incurred in respect of the application 25 for preparation making and confirmation of this Order shall be paid by the district council as part of their expenses under the Public Health (Ireland) Acts 1878 to 1907.
 - 3. This Order may be cited as the Carlow (Castle Hill) Order 1913.

- 2. The costs and expenses of the district council and the Local Government Board for Ireland incurred in respect of the application for 15 preparation making and confirmation of this Order shall be paid by the district council out of the rate applicable by that council to defray the expenses incurred by them in the execution of the Public Health (Ireland) Acts 1878 to 1907.
 - 3. This Order may be cited as the Galway Order 1913.

The costs and expenses of the corporation and of the Local Government Board for Ireland incurred in respect of the application for preparation making and confirmation of this Order shall be paid 15 by the corporation as part of their expenses under the Public Health (Ireland) Acts 1878 to 1907.
- 3. This Order may be cited as the Dublin (Carter's Lane) Order 1913.
