Clause 1, *agreed to.*

Clause 2 :

Amendment proposed, in page 1, line 10, after the word “when,” to insert the words “an advance is made in pursuance of”—(Mr. *Atkinson*).—Question, That those words be there inserted,—put, and *agreed to.*

Another Amendment proposed, in page 1, line 10, to leave out the word “applies”—(Mr. *Atkinson*).—Question, That the word “applies” stand part of the Clause,—put, and *negatived.*

Clause, as amended, *agreed to.*

Clause 3, *agreed to.*

Ordered, to Report the Bill, as amended, to the House.
